Therefore I tell you, every sin and blasphemy will be forgiven men, but the blasphemy against the Spirit will not be forgiven. And whoever says a word against the Son of man will be forgiven, but whoever speaks against the Holy Spirit will not be forgiven, either in this age or in the age to come (Matthew 12:31-32, RSV).



is that there are many who have inquiring

minds. So it was, on one day after Ash Wednesday, that one such soul wandered into my office and wanted to know what Scripture meant by an unforgivable sin, and, more specifically, what it meant by "blasphemy of the Holy Spirit." After all, if God is love, how can there be any unforgivable sin? I have to admit that it had been a long time since I'd thought about this passage in which Jesus is addressing the Pharisees who were accusing him of being Beelzebul, the prince of the demons and the rival of the God of Israel. I confessed my ignorance (Lent is a good time for confessing), and I went to a commentary to see what it had to offer for insight. I thought that if one person was asking about this, there must be others who have wondered about the same thing, so I offer these thoughts to you.

Going back to the early church fathers, known as the Patristic

ne of God's blessings that Period (the word patristic comes from I have found at St. Peter's the Latin word *patēr*, father), lasting from around 100 AD to the Council parishioners in the church of Chalcedon (451), and even beyond to 700 AD, we find some interesting guidance. Hilary of Poitiers (c. 315-67) believed that to blaspheme the Holy Spirit was to deny God in Christ. "To forsake Christ is to forsake the nature of the Spirit of the Father residing in him. For Jesus fulfills every work in the Spirit of God, is himself the kingdom of heaven, and in him God is reconciling the world to himself. Therefore any blasphemy aimed at Christ is aimed at God, because God is in Christ and Christ is in God." In the context of the Pharisees' refusal to recognize God in Jesus, accusing him of being Beelzebul, was blasphemy of the Holy Spirit.

> John Chrysostom (c. 347-407) thought that people could be ignorant of who Jesus was but they could not be ignorant of who the Holy Spirit was, "... due to their own previous experience. For the prophets had spoken through the Spirit. The Old Testament as a whole had an

exalted understanding of the Holy Spirit. What he [Jesus] says, then, is this: 'So be it – you may be offended at me, because of the humanity I have assumed. But you cannot say the same of the Holy Spirit. You cannot claim not to know the Spirit. Therefore your blasphemy has no excuse, and you will suffer the consequences both here and hereafter."  $^{2}$ 

Severus (c. 465-538) was stricter in his interpretation. People could claim ignorance of the mystery of God's self-abasement as a man. "But in their blasphemy they heaped insults against the divine signs he [Jesus] manifested and the many miracles he worked through the Spirit who was in him and who is of the same essence [the same substance as Jesus]. They exclaimed, 'He casts out demons by the prince of demons.' Those insults ... Christ says they shall not be forgiven. They could not use ignorance as a pretext for their defense.""

Augustine of Hippo (354-438) I find the most helpful. For him, "... it is unrepentance that is a blasphemy against the Spirit." By refusing God's love to forgive one's sins by remaining unrepentant, one rejects the Holy Spirit which communicates God's love. "You are speaking a very evil, utterly graceless word against the Holy Spirit ... if when the patience of God is beckoning you to repentance, you harden your impenitent heart. By doing so you store up wrath for yourself on the day of wrath and of the revelation of the just judgment of God, who will render to us all according to our works [on the Judgment Day]." God's grace is always available, but as long as one rejects it one will never be forgiven.

A modern commentator, M. Eugene Boring, makes the point that, "In Matthew's context, the sayings (vv. 31-32) are not speculative statements about which sin(s) may be unpardonable, but a pronouncement of judgment against the Pharisees. In Matthew, the Pharisees represent the kingdom of Satan, those who have already decided to kill Jesus (12:14), who block others from entering the kingdom of God (23:13), who are not planted by God but represent Satan's work (15:13-14) and are destined for condemnation at the final judgment.... [S]uch pronouncements function as warnings to church members and especially to church leaders. [Church members' and church leaders'] function is not to provide a doctrinal category of "unforgivable sins" about which Christians should be anxious."

I am partial to Augustine's interpretation of Matthew 12:31-32. God is love and yet if we reject his love, communicated by the Holy Spirit through absolution, by refusing to receive his forgiveness, then we have condemned ourselves. Stubborn unrepentance dooms one to condemnation. Thank goodness that decision is God's to make. It is not our job to decide what sin(s) is/(are) unforgivable, as Boring suggests, but to live in the Easter joy of Jesus' resurrection which promises us eternal life and gives us the ability to admit our wrongs and, with penitent hearts, be forgiven.





#### Palm Sunday – April 2

Millie will talk to Dot on the number of palms and palmettos for the crosses to order and provide Laura the count to purchase. Vel had given a folder with all information for Palm Sunday to Laura. Millie will work with Laura on the Palm Sunday Palm order from the florist.

#### Tenebrae – Wednesday, April 5, 7:00 P.M.

There is no Eucharist or music at this service. The service is from The Book of Occasional Services. This is a dark service, and the lights are dimmed from the beginning. Copies in larger print will be made for the readers. Readers may need to bring a flashlight; it was discussed to use the pulpit lights since no one knew if the batteries will last long enough.

The readers' Candelabras are positioned at the bottom of the steps. The Christ candle is taken to the Sacristy where it cannot be seen. There is nothing on the altar. The Credence Table can stay as normally set. No need for a vested acolyte.

Father Jim to ask Galilee if we could borrow a cymbal for the loud noise in the service.

#### Maundy Thursday – Rite II at 7:00 P.M. with Eucharist

Millie will check how many attended this service last year for setting communion up. The lights are not dimmed during this service.

Father Jim will do a foot-washing during this service. This is strictly optional. A chair, basin of warm water, towel, will be stationed ready after the Creed. The Acolyte or LEM will bring the items between and center to the choir pews close to the end of the steps. It was suggested along with Father Jim, Kimberly also do the foot washing.

Stripping of the altar is done while the congregation is reading Psalm 51. Remove all items from the Altar - candles, elements etc. Put in Sacristy. Keep the Christ candle lit. The ambry door should be left ajar.

#### Seder Dinner – Potluck 5:45-6:45 P.M.

It was discussed and all felt we are trying to do with 30 people what we used to do with 60 people. The Seder Dinner will not be held this year. A potluck dinner will be held instead. Paper products will be used for easy and quick cleanup.

# **Church Open After Maundy Thursday Service?**

Father Jim will announce to the congregation to see if there is enough interest to keep the church open after the Maundy Thursday service. What the hours will be to keep the church open depends on the response. A concern is for everyone who may come that everyone is safe. Also asking for security volunteers so no one is here alone.

#### **Vestry Meeting Minutes**

#### **January 9, 2023**

The St. Peter's Vestry met together in the Diffenbaugh Library ay 7 P.M. on January 9, 2023. Attending the meeting were Fr. Jim Hunter, Interim Rector; returning vestry members Kimberly Truxell, Sr. Warden; Debbie Whitehorne, Jr. Warden, plus newly-elected vestry members Bruce Comfort, Vel Shreve, Linsey Shreve, Charlie Pfeifer, Judy Eller, Peggy Pfeifer, Liz Kress, and Howard Belote. Also present was John Eidam+.

The meeting opened with the first half of the Evening Prayer service. John+ followed to thank the vestry for its support of his feed-the-homeless ministry. Following his well-received remarks, John+ departed.

<u>Vestry Officers and Terms</u>: Fr. Jim stated he asked Kimberly to be Senior Warden before the Vestry meeting. He was later informed that the Senior Warden and Junior Warden are elected by the Vestry in the Diocese of Southern Virginia. He then asked that the Vestry vote to affirm his choice of Kimberly. There were no objections and Kimberly was elected by acclimation. Nominations were opened for Jr. Warden. Debbie Whitehorne and Bruce Comfort were nominated. The vestry voted by paper ballots that were counted by Jim+, and Bruce was elected.

By Canon, one-third of the vestry should be elected every year. At our Parish Meeting on January 8<sup>th</sup>, we inadvertently elected an extra person so for 2023 we have a 10-member vestry. In order to be able to elect three new members each year and remain at a total of 9 vestry members, some of the newly-elected vestry members would have to serve shortened terms. However, if a person rolls off the vestry having filled a shortened term, they are eligible to run for the next year without taking a year off. Jim asked if anyone was willing to volunteer for a shorter than a three-year term. Bruce, Vel and Linsey volunteered for a one-year term. Charlie and Judy volunteered for a two-year term. The result is as follows:

Kimberly, Bruce, Vel, and Linsey will serve through the end of 2023, Debbie, Charlie, and Judy will serve through the end of 2024,

Peggy, Liz, and Howard will serve through the end of 2025.

Charlie was elected by acclimation to serve for another year as Treasurer. After 15 years, Peggy is stepping down as Registrar. Charlie agreed to take notes, and these minutes are the result. We need to identify Peggy's successor before the February meeting.

<u>December 2022 Minutes:</u> The December meeting minutes were emailed to Jim, the Wardens, and Laura Kallestad prior to the meeting. Kimberly recommended a couple of minor corrections, and the vestry approved the minutes as amended.

**Finance Report:** Charlie reviewed the December Financial Report with the vestry.

The Cash Account Balances for December 2022 are as follows:

Operating Account: \$22,998.88

Money Market Account \$50,063.53

Composite Fund: \$62,911.85

CH Discretionary Fund \$3,219.44

Total Net Assets: \$139,193.70

- A motion was made and seconded that the financial report be approved, and the vestry approved the report.
- Charlie reported that additional pledges received after the budget was presented to the congregation at the annual meeting resulted in pledges increasing by just over \$8,000 compared to 2022.
- A total of twenty-nine pledges totaling \$131,090 have been received. Three of the pledges exceed \$200/week, 8 pledges have increased. The average pledge for 2023 is \$86.93 per week.

# St. Peter's Episcopal Church Vestry Meeting Minutes January 2023

#### **Rector's Report:**

- Jim+ reported his activities for the month.
- Jim+ handed out a Vestry organizational chart proposal. He asked for Vestry representatives to be a liaison to each parish ministry. He asked each vestry member to pick the areas that best fit their strengths.
- Jim+ would like the parish to develop By-Laws. This task will take some time, but he will supply one or more examples to help with the project.

#### Senior Warden's Report:

- Kimberly discussed having counters to receive the Sunday offering and prepare the paperwork for turnover to the treasurer. There are necessary cash controls that fell by the wayside during Covid.
- The 2021 parish books were audited internally by Carolyn King and submitted to the Vestry and the Diocese. We will ask Carolyn King to audit the 2022 parish books.

#### Junior Warden's Report:

- <u>Safe Church:</u> We are waiting for the government to decide when to open the process for applying for a grant to improve the safety and security of the property and occupants.
- Youth: Lynn McFarlin from the Diocesan Staff met with Debbie on December 19<sup>th</sup>, 2022, to discuss the opportunities for the Sunday School and the Youth outside the church. Opportunities to join with other parishes seemed to be the most practical.

#### **Old Business:**

- White Door Safety Lock and Doorbell: This has not yet been installed. It will be scheduled after the first of the year.
- Parish Hall Steeple: Bruce has a \$11,000 bid to remove the steeple. He is still exploring alternatives.
- <u>Transition Team:</u> Bruce will chair the transition team that is being formed now. The consensus was that this transition process would take the place of a Staff and Vestry Retreat this year.

#### **New Business:**

- <u>Parish Hall Rental:</u> Parish Hall rental fees and regulations were discussed. It was decided that a refundable security deposit of \$100 and a rental fee of \$25 per hour would go into effect now with possible changes in the future. The kitchen can only be used for warming food prepared at another location.
- <u>Beer/Wine at Parish Events:</u> The Vestry revisited the long-held policy of not having alcohol allowed at parish events. The consensus was that we should not change the policy at this time.

There being no further business, the meeting was moved to be adjourned. The motion was seconded. The meeting was adjourned and closed with conclusion of The Evening Prayer service followed by The Lord's Prayer.




